

Anchorage Native Musicale Instructions & Forms

INSTRUCTIONS FOR NATIVE MUSICALE PERFORMERS

The attached 4 forms must be completed and turned in to the Backstage Staff:

1. **Information Sheet** - This information will be used by the Radio Announcer, so fill it out completely. The Radio Announcer uses the information you've provided on this sheet while performers are exiting and entering the stage. Have it ready BEFORE your performance and hand it to Backstage Staff the night of your performance.
2. **Copyright Page** - This information is required for tape and videotape production. Write down the information you find with the song. Name of song, writer, composer, and copyright holder. Give this form to the Backstage Staff on the night of your performance.
3. **Performance Release** - Please fill this out and sign it. Group leaders, have all group members sign it. Bring this to the Backstage Staff the night of your performance.
4. **Release & Waiver of Liability and Indemnity Agreement** - Please fill this out and sign it. Group leaders, have all group members sign it. Bring this to the Backstage Staff the night of your performance.

OTHER INSTRUCTIONS: Microphones: The microphones are shut off while they are being moved to the next group. Do not speak into them until the Stage Manager has finished moving them. The microphones are set up 1, 2, 3, 4 from left to right on stage which correspond to our sound board upstairs (Control Room). Please keep the microphones in order for better performance.

Concerning Accompaniment: If you require accompaniment, you should let the Stage Manager know *before* your performance. Let the Musicians onstage know *beforehand*, the Key to your song. If you do not need accompaniment, let the Stage Manager know this too. If you will be playing for your group, *please tune up your instrument before getting onstage!* If your guitar takes batteries, please make sure to have new batteries installed before your performance.

All Performers:

- Note that each group has been given a **total of 10 minutes**. Please **stay within that time** frame. Please don't make us have to usher you offstage by going over your scheduled time.
- Be at ChangePoint Auditorium early on the night of your performance.
- Keep your group together by sitting in the section reserved for performers.
- Group Leaders: Only those that practice with you should be allowed to perform.
- **No pre-recorded music.**
- Remember to have all your paper work completely filled out when you come backstage!

Form 4 of 4 RELEASE & WAIVER OF LIABILITY & INDEMNITY AGREEMENT

ANCHORAGE NATIVE NEW LIFE MUSICALE

CHANGEPOINT AUDITORIUM

IN CONSIDERATION of being permitted to enter for any purpose any RESTRICTED AREA (herein defined as the degrees to which admission by general public spectators is prohibited), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, EACH OF THE UNDERSIGNED, for himself, his personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he enters and with which he comes in contact, and he does further warrant that his entry upon such restricted area or areas and his participation, if any, in the event constitutes an acknowledgement that he has inspected such restricted area and that if, at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the restricted area(s):

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, other participants, operators, officials, any persons in any restricted area, sponsors, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "releasees", from all liability to the undersigned, his personal representatives, assigns, heirs and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence or the releasees or other wise while the undersigned is in or upon the restricted area, and/or, competing in, observing, working for, or for any purpose participating in the event.

2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purposing participating in the event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities could be dangerous and involved the risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal for and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
